

# Max Calc Terms of Use

This document effective as of July 28, 2024

## Welcome to Max Calc!

These Terms of Use ("Terms") govern your access and use of the Max Calc mobile application ("App") developed by Anatoly Mazkun ("we", "us", or "our"). By downloading, installing, or using the App, you agree to be bound by these Terms. If you disagree with any part of these Terms, then you may not access or use the App.

## 1. Description of Services

Max Calc is a mobile application that provides the following functionalities:

- Basic calculator functions (addition, subtraction, multiplication, division)
- Accounting calculator functions (e.g., percentage calculations)
